Quality Measurement and Reporting During COVID-19 and Beyond

MNCM recognizes the current COVID-19 situation will have significant implications for health care quality performance in 2020 and beyond, and that adjustments may be needed in the approach for quality measurement and reporting in both the short and long term. MNCM is carefully monitoring activities at the federal and state levels that will have implications for quality measurement here in Minnesota. In June, MNCM will engage the Measurement and Reporting Committee (MARC) to develop recommendations on the approach for quality measurement and reporting for 2020 and beyond. The recommendations will be shared with the community for broader input before final determinations are made. MNCM welcomes information from stakeholders on efforts to analyze and estimate the impacts of COVID-19 on clinical quality performance and actions being taken to mitigate impacts to quality of care. In Case You Missed It

IMPACT OF COVID-19 ON 2020 DATA COLLECTION CYCLE

MNCM understands the expected impact of COVID-19 in the coming days and weeks is presenting challenges for all our stakeholders. Because 2020 data collection was largely complete before major COVID-19-related disruptions began, MNCM is on track to complete 2020 quality measure results on time and is working with stakeholders on a case-by-case basis to accommodate extensions as needed. MNCM plans to send preliminary statewide results for Direct Data Submission (DDS) measures to medical groups for a two-week review and comment period beginning Monday, April 13, and concluding on Monday, April 27. Medical groups that anticipate they will be unable to complete data submission by Friday, April 10, or complete all requested review by Friday, April 24, should reach out to MNCM at *support@mncm.org* or 612-746-4522.

2019 MINNESOTA HEALTH CARE QUALITY REPORT RELEASED

On February 13, 2020, MNCM released its annual report highlighting health care quality measures for medical groups and clinics in Minnesota. The *2019 Minnesota Health Care Quality Report* includes data on measures for preventive care, care for chronic conditions like diabetes and heart disease, depression care, and other measures. An appendix to the report includes detailed quality information for 213 medical groups and 948 clinics in Minnesota and neighboring states, and consumers can also search the data using an interactive tool at *www.mnhealthscores.org*.

Congratulations to the nine medical groups that achieved high performance on at least 50 percent of the measures they were eligible for, including: Central Pediatrics, Entira Family Clinics, Essentia Health, HealthPartners Central Minnesota Clinics, HealthPartners Clinics, Mankato Clinic, Park Nicollet Health Services, South Lake Pediatrics, and Wayzata Children's Clinics.

NEW INFOGRAPHIC RELEASED: COLORECTAL CANCER SCREENING IN MINNESOTA

On March 11, 2020, MNCM released a new *Colorectal Cancer Screening in Minnesota* infographic that highlights colorectal screening rates by county, age group, and sex, with details on the proportion of up-to-date screenings by type. It also calls out three key areas with opportunities for improvement. The infographic features data from the 2019 report year reflecting 2018 dates of service.
