Letter from MNCM President and CEO Julie Sonier

Greetings, and happy summer!

As the possibility of returning to life resembling what we knew as "normal" before 2020 draws ever closer, we also know there are some things that should never go back to the way they were before. An example is the potential of telehealth to permanently change the landscape of health care delivery, and the opportunity we have to be intentional and data-driven in ensuring that we reap the gains and avoid potential pitfalls that could reduce quality or increase cost in the long run. Measurement and Reporting Update

The Measurement and Reporting Committee (MARC) met at the beginning of June and welcomed five new members:

The committee previewed preliminary results from the 2020 measurement year (2020 dates of service) and provided additional input on the factors that may have contributed to the difference in measurement outcomes for care delivered in 2020 as a result of the COVID-19 pandemic. Additionally, MNCM will be releasing a special spotlight report as well as individual measure briefs in early August, which will summarize and display the impact of COVID-19 on quality measurement for care delivered in 2020.





CHIRP Pilot Project Recruitment Notice

MNCM is inviting organizations to participate in pilot testing of the Common Health Information Reporting Partnership (CHIRP) standards. This is a collaborative effort aimed at creating efficiencies, reducing duplication, and streamlining the exchange of clinical and claims information between payers and providers. Ultimately, this effort seeks to improve care coordination and patient health and well-being.

Benefits of participation in the pilot include having the opportunity to provide input and shape the standards, ensuring that they are implemented in a way that meets the expressed needs (e.g., timely and more up-to-date information, ease of combining data from multiple entities, reduced variation in data requests). In order to have a representative and informative pilot, we need payers and providers to volunteer to participate!

MNCM is seeking two payers and two provider groups to participate in the pilot. MN Clinics Onboard to New PIPE System for Data Submission – Congratulations to PIPE Early Adopters

MNCM is continuing to onboard clinics into the new data collection and measure calculation technology known as PIPE (Process Intelligence Performance Engine). PIPE will replace the older system known as DDS (Direct Data Submission) to reduce provider reporting burden and increase the availability of timely and actionable data for clinics to use in their improvement efforts.

Both systems will be available for the next two reporting cycles with the goal of moving all clinics statewide to PIPE by the end of 2023. MNCM will be rolling out a plan for statewide onboarding this fall and scheduling implementations over the next two years. MNCARES Portal Now Open for Data Submission

MNCM has been working in collaboration with HealthPartners Institute and the Minnesota Department of Health on the *Minnesota Care Coordination Effectiveness Study (MNCARES)* and has completed development of the MNCARES data portal to receive data from Minnesota Health Care Home (HCH) clinics participating in the study.

Because COVID-19 disrupted care coordination for many patients, two patient cohorts (pre- and post-COVID-19) will be studied for comparative effectiveness analysis. The Historical patient cohort will include patients enrolled in care coordination before COVID-19 impact, while the Primary patient cohort will include patients enrolled in care coordination after COVID-19 impact. The first data submission for the Historical cohort is open now through August 15. The Primary cohort will be submitted in the spring of 2022.

A total of 329 clinics across 48 organizations have agreed to participate – 85% of eligible HCH clinics in Minnesota. Participating clinics can find more information about submitting data on the *MNCARES Information Page for Clinics*.

MNCM SPRING WEBINARS AVAILABLE FOR VIEWING ONLINE

- » In April, MNCM hosted a webinar, **Welcome to MNCARES! A Study to Inform Care Coordination Strategies**, that introduced the community to a study led by the HealthPartners Institute, in collaboration with the Minnesota Department of Health and MN Community Measurement. The three organizations were awarded funding from the Patient-Centered Outcomes Research Institute (PCORI) to study the effect of care coordination on patient outcomes. The purpose of MNCARES is to compare two approaches to care coordination for patients with complex health and social issues. This webinar highlights progress made in preparation for the official launch of the study activities in spring of 2021, and discusses how Minnesota Health Care Home Clinics, health plans, and patients will be engaged with the study. - » MNCM hosted a webinar during May 2021 as part of Mental Health Awareness Month, Improving Together: Advancing Mental Health Outcomes in Minnesota. During the webinar, Dr. Angeline Carlson and Deb Krause shared highlights from a project funded by a prestigious Eugene B. Washington Community Engagement Award from the Patient-Centered Outcomes Research Institute (PCORI). The project used a Mixed Methods approach to engage diverse stakeholders, including Minnesota Department of Health, employers, health plans, providers, and nonprofit organizations. The presenters highlighted key findings regarding clinical practices, community perspectives, and opportunities for collective action. In addition, resources were shared to educate stakeholders and empower action. The webinar recording and slides can be accessed here.
